EXCITING TRILOGY DATA USHERS IN NEW METROCARE TRILOGY INITIATIVE

In 2018, MetroCare and HealthChoice began working with a small number of Trilogy practices to establish a Medicare ACO.

As part of this trial project, MetroCare worked closely with these practices to increase Medicare Annual Wellness Visits to promote preventive care, increase quality and value, and increase practice revenue.

New data just in on the results of these efforts is quite remarkable. Across the ACO, there was a 51% increase in AWVs performed, and three practices showed greater than a 300% increase in Medicare Annual Wellness visits.



The results of regular preventive care cannot be ignored:

- Increased practice revenue Increased patient loyalty Fewer care gaps
- Increased documentation->increased risk adjustment scores --> Increased opportunity for shared savings
- And even more importantly, prevention or improved control of patient illness resulting in better

quality of life and lower healthcare cost.

This year our goal at MetroCare is to encourage an increase in preventive services in our Trilogy commercial patient population through practice education seminars and close personal involvement in our practices.
