### **Serious Decrease in Medicare Revenue for 2024**

The change that everyone will notice from the 2024 Physician Fee Schedule Final Rule is the 3.4% drop in the conversion factor, which will result in a 1.25% decrease across your overall fee schedule. It may not sound that bad until you think about the cumulative 26% decreases over the last 25 years.

And, as we all know, commercial payers tend to base their fee schedules as a percentage of what Medicare pays, so there can be negative downstream effects. Unlike commercial payers, the fee schedule for CMS can only be addressed through federal legislation. There is a small possibility of a "fix" from Congress in January in response to massive feedback.

Make your voices heard regarding your dissatisfaction with the upcoming changes in the conversion factor for 2024. CMS 2024 Physician Fee Schedule Final Rule
High Level View of a Few Big Things

- 1. **Conversion Factor Reduction: 3.37%** unless Congress implements a "fix" in January. Please see the article above with information on how to contact our representatives in Washington to ask for their help.
- 2. Add-on code G2211 that compensates for maintaining a longitudinal relationship and managing complicated illness will be activated after years of delays due to fears of excess cost. Intended to help PCPs, who generally manage more than they are ever compensated for, many specialty associations are now putting out information on billing this code. Beware the likely compliance pitfalls. Look for more details to come in 2024 on proper use of this code.
- 3. Compensation for screening for social determinants will become and add-on code to AWV and E&M visits.
- 4. Funding to pay practices for coordinating community resources in response to problems discovered through SDOH screening is provided with specific requirements.
- 5. **Principle Illness Navigators** funding will pay for specifically trained navigators to help patients obtain all aspects of care for a complicated illness such as cancer.
