

# The Clarity Plan

A modern, predictable copay-only medical plan that offers cost savings and helps your patients make confident decisions. It is designed to support simpler benefit structures and provide more predictable out-of-pocket costs for your patients, with no deductibles and no coinsurance.

Launching on July 1, 2026, it uses the Cigna Healthcare Open Access Plus (OAP) network and works for any type of care from office visits to surgical procedures to imaging. Your patients go to the myCigna® app or [myCigna.com](http://myCigna.com) and use the online 'find care' tool to search for care and see total out-of-pocket costs – as a single copay – before or while making an appointment.

You are participating with the Clarity plan because of your participation in the Cigna Healthcare OAP network. All existing Cigna Healthcare network contract terms, including reimbursement rates and electronic payment processes apply to your patients with Clarity coverage. The patient copay does not affect your fee schedule.

The plan is administered on the Allegiance platform, which has been a wholly owned Cigna Healthcare third-party administrator for over a decade. Allegiance will be responsible for core plan operations, including claims processing, customer service, provider service, utilization management and case management clinical support.
