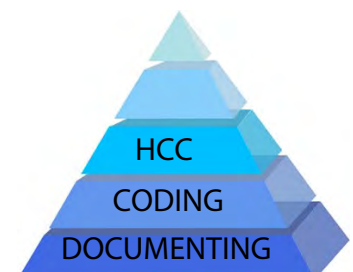

## Cigna Revenue Update: Modifier 26 – Professional Component change in payment

Effective for claims processed July 1 and after, Cigna will reduce reimbursement to \$5 for Current Procedural Terminology (CPT®) codes billed with modifier 26 when the professional component/technical component (PC/TC) payment indicator is 3 or 9.
