# **UPDATE: SPECIFICS ON ADDICTION CME FOR DEA CERTIFICATE**

The MATE Act, intended to broaden access to addiction treatment medication, eliminates a previously required waiver to prescribe for addiction treatment and requires all DEA certificate holders to attest, one time only, to having eight hours of training for evaluating and treating substance use disorders. The specific CME requirements for those with pending summer DEA certificate applications and renewals may be satisfied by a variety approved methods as seen in the table on the right.

Training previously obtained in one of the programs listed in the table on the right, or a combination of 8 hours of substance abuse related CME obtained over time for state medical license renewals are acceptable. Four two-hour blocks of prescribing CME acquired from SVMIC for repeated TN state license renewals since 2014 is sufficient to allow attestation for your DEA renewal.

#### **REQUIREMENT ALREADY SATISFIED:**

- 1. Board certification in Addiction Medicine or Addiction Psychiatry by ABMS, AABA or AOA
- 2. Completed DATA-2000 waiver training
- Graduated in the last five years in good standing from a medical, APN or PA school with <u>>8 hour</u> curriculum in substance use disorders
- 4. Previous completion of total of 8 hours pertinent CME

# **ON HOLD AGAIN: CIGNA'S NEW 25 MODIFIER POLICY**

After protests from many fronts, including significant pushback from the AMA, on May 22 Cigna quietly updated the banner on the M25 modifier policy pdf on its website to indicate that their new 25 modifier documentation submission policy is on hold. Click here to view/download

Cigna states that they are continuing to review this policy for future implementation, and other payers are taking a hard look at Modifier 25 as well. This modifier has always been a magnet for compliance issues and misuse. We do not expect this issue to go away over time. As always, we are following up with Cigna and watching for changes in other payer policies so that we may continue to bring you timely updates.

#### IMMEDIATE CHANGES:

For those who are providing telehealth encounters via non-HIPAA compliant platforms such as face time, the emergency waiver that allowed use of these platforms has expired rendering them no longer acceptable.

Coverage for vaccines and provider administered testing will be based on in-network status and may include deductible/ copay depending on the patient's health plan.
