# ARE YOU READY TO PARTICIPATE IN A MEDICARE ACO?

#### CMS Wants All Their Traditional Medicare Patients in an MSSP Program by 2030

On August 30, 2022, a press release from CMS announced the overwhelming success of its Medicare Shared Savings Program in saving **\$1.66 billion** in 2021 when compared to expected expenditures for that year. For five consecutive years, this program has generated savings while bringing quality performance by meeting quality goals and preserving resources by employing evidence-based best practices.

Officials from Health and Human Services and Centers for Medicare and Medicaid Services announced this success while sharing strategic plans for their expansion over the coming years with a goal of increasing savings and quality while delivering person-centered care that works toward erasing health disparities.

The success of the shared savings programs has led CMS to set a goal of enveloping 100% of its traditional Medicare patients into an MSSP ACO by 2030. The implication is that if you continue to treat traditional Medicare patients, you will eventually be participating in an MSSP.

## HOW DOES RISK CODING AFFECT COST SAVINGS CALCULATIONS?

CMS figures the total cost of a patient's care from claims data, adjusting for chronic conditions that tend to generate high expenditures and use more resources.

Properly coding and reporting those conditions in your patients to indicate their exact nature allows CMS to adjust their spending expectations upward as needed to set aside sufficient funds to cover the cost of care for your patients.

Quality preventive care allows you to demonstrate savings from preventing a decline in health and increase in expenditures due to unchecked chronic disease processes. This is not only how shared savings are generated, but also how your

quality of care is weighed in the cost category of MIPS. No matter how well you provide quality care, if costs are higher than expected from the diagnoses that you code, your opportunity to share in the savings and your overall MIPS cost category score will suffer. CLICK HERE FOR MORE INFORMATION
