MetroCare is again bringing Steve Adams, dynamic speaker and expert in documentation and coding for risk, to Memphis to present a seminar on hierarchical condition category coding to our physicians and their staff at the Fogelman Executive Center on the University of Memphis campus.

This year we are sharing coding data from our network claims, analyzed by Optum, to allow the presentation to focus on opportunities for improvement specific to our network goals.

# New Addiction Medicine Resource for Memphis

Integrated Addiction Care (IAC) utilizes both in-person and telemedicine to treat patients with alcohol use disorder as well as a range of substance use disorders/polypharmacy (opioids, benzodiazepines, methamphetamine, cannabis, crack/cocaine).

An interprofessional team consisting of the region's only fellowship-trained addiction medicine specialists boarded in both addiction and family medicine, a behavioralist, nurse care manager and case manager works collaboratively in one office, integrating care to address addiction, physical health issues (as necessary), mental health and social determinants of health.

Medication-assisted treatment (MAT), counseling, an intensive outpatient program (IOP), and carefully planned case management make IAC a "one-stop shop" for patients with addictions, including high-acuity individuals with co-occurring mental and physical health conditions and women with substance-exposed pregnancies.

IAC's goal is to move patients into durable recovery by tackling social issues that are a barrier to functionality.

TennCare, Medicare and major insurance plans are accepted. Appointments can be arranged for the same or next day of a call (tel 901 746 9438). Walk-ins are accepted.
